



## The 2025 New Hope Arts and Crafts Festival September 27th and 28th Exhibitor Information

Set-up: Saturday Morning Booth Size: 10' x 10'

Bring your own Straight-legged Tent - OUTDOORS Rain or Shine

No Friday night set-up. There is 24 hour security on site. Booths stay set up overnight on Saturday.

Early bird discount if Postmarked by March 1st: \$265, \$315 Premium

**By April 20: \$290 - \$340 Premium**

**April 21- Aug 31: \$315, \$365 Premium**

Last Minute, if available, Sept 1 - Sept 20:

\$350, \$400 Premium

**Admin Fee: \$25**

Two checks - one for admin fee (\$25) and one for booth fee.

Checks made to:

"Greater New Hope Chamber of Commerce" plus check or credit card information for booth fee.

**Notification of Acceptance** acceptance is on a rolling schedule - you will receive word usually within 4 weeks of our receipt of your application

Once accepted exhibitors will receive an email about 3 weeks prior to the festival with information and instructions regarding arrival, designated parking, set-up times, booth location, special events, etc. Free parking is available during Festival for all exhibitors behind the high school for one vehicle and paid parking for extra vehicles. Free overnight parking for RV with prior notice (no facilities). Let us know about any special needs by filling out the application completely. ### **Exhibitor Jury and Show Judging:**

A jury of arts and crafts professionals will determine the exhibitors of the Festival. All applicants must email 5-7 jpegs of your work including one image of your booth. Higher resolution images are best and may be used in print advertising. On Saturday of the show, prize ribbons will be awarded to 3 winners in each category and Best in Show, by a panel of prestigious show judges, which are different than the jury and change yearly.

### **Application Prices and Due Dates:**

A 10' x 10' booth space for the entire weekend is \$290, with premium spots at \$340 if received by April 20th (Premium Spots are in areas near entrances at W. Bridge St and the Bus Stop/Food Court OR are Corner Paved OR Grass spaces.) There is also a \$25 non-refundable admin fee which must be paid by check and which will be cashed upon receipt.

The completed Exhibitor Application must be submitted with two separate checks, each made out to Greater New Hope Chamber of Commerce or with a check for the administration fee and complete credit card information. Admin checks will be cashed on receipt. All accepted exhibitor booth fee checks will be cashed on acceptance. All others will be shredded or wait-listed on request. Credit cards will be charged upon acceptance.

Notification of acceptance/non-acceptance will be within 4 weeks of our receipt of your application

Applications postmarked by **March 1st, 2025** will receive a discounted rate of \$265, or \$315 for a premium booth for checks only. No credit cards for discounted rates.

Applications received by April 20th fees are \$290 and \$340 for premium

Applications from April 21st - August 31 will be \$315, and \$365 for premium.

From Sept 1-20th, if available, will be \$350, \$400 Premium.

There will be a \$35 fee for any bank returned checks.

### **Cancellation Policy:**

Cancellations prior to **April 20, 2024** will receive a refund of booth fee, but not admin fee.

Cancellations up to eight (8) weeks prior to the festival will receive a 50% refund of booth fee.

There will be no refunds for cancellations within eight (8) weeks of the Festival.

If The Festival is canceled due to PA State mandates or weather, all booth fees will be refunded within 30 days of the cancellation date.
